BAC RESOLUTION NO. 2024 – 424

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF TONERS FOR THE EXISTING COPIER MACHINE FOR THE CITY AGRICULTURE DEPARTMENT BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH DIRECT CONTRACTING PER SECTION 50 (C), RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184;

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Direct Contracting as provided in Section 50, Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Agricultural Department** of toners for their existing Kyocera copier machine, the **Bids and Awards Committee** recommends that the procurement of the same be done through Direct Contracting as per **Section 50 (C), Rule XVI of Republic Act 9184** as shown in the attached **Purchase Request No.240973**;

WHEREAS, the Kyocera Copier Machine of the **City Agriculture Department**, was purchased at **Philcopy Corporation**. with business address at **#140 – B Real St. District 21, Ormoc City** thus, the aforementioned items are awarded to them as per attached price quotation with a total amount of **FIFTY-NINE THOUSAND TWO HUNDRED EIGHTY PESOS ONLY (Php 59,280.00)** only:


