BAC RESOLUTION NO. 2024 – 423

A RESOLUTION RECOMMENDING THAT THE PROCUREMENT OF TONERS AND RIBBON KIT FOR THE EXISTING PHOTOCOPIER MACHINE FOR THE OFFICE OF THE SENIOR CITIZEN BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH DIRECT CONTRACTING PER SECTION 50 (C), RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184;

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Direct Contracting as provided in Section 50, Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **Office of the Senior Citizen** of toners and ribbon kit for their existing Kyocera ecosys photocopier machine, the **Bids and Awards Committee** recommends that the procurement of the same be done through Direct Contracting as per **Section 50 (C), Rule XVI of Republic Act 9184** as shown in the attached **Purchase Request No.240648;**

WHEREAS, the Kyocera Photocopier Machine of the **Office of the Senior Citizen**, was purchased at **Philcopy Corporation**. with business address at **#140 – B Real St. District 21, Ormoc City** thus, the aforementioned items are awarded to them as per attached price quotation with a total amount of **TWO HUNDRED NINETY-FOUR THOUSAND FOUR HUNDRED PESOS ONLY (Php 294,400.00)** only:
