BAC RESOLUTION NO. 2024-228

A RESOLUTION RECOMMENDING THAT THE ELECTRIC SERVICES FOR THE CITY MAYOR'S OFFICE BE DONE THROUGH THE ALTERNATIVE MODE OF PROCUREMENT, PARTICULARLY THROUGH DIRECT CONTRACTING PER SECTION 50 (C), RULE XVI OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 9184;

WHEREAS, in accordance with Section 10 of the Implementing Rules and Regulations of Republic Act 9184, as a general rule, Procuring Entities shall adopt public bidding as a general mode of **procurement**, however, in order to promote economy and efficiency and during exceptional cases, it may resort to alternative modes of procurement such as Direct Contracting as provided in Section 50, Rule XVI of the said Implementing Rules;

WHEREAS, to promote economy and efficiency and to address the urgent need of the **City Mayor's Office** for electric services of Philippine Red Cross for CY 2024, the **Bids and Awards Committee** recommends that the procurement of the same be done through Direct Contracting as per **Section 50 (C), Rule XVI of Republic Act 9184** following Appendix 21, re; Guidelines on Procurement of Water, Electricity, Telecommunications and Internet Service Providers of the same IRR as **shown in the attached Purchase Request No.240647;**

WHEREAS, LEYTE V ELECTRIC COOPERATIVE, INC. with business address at **Brgy. San Pablo, Ormoc City, Leyte** is the only electricity service providers who exclusively operates within Ormoc City and Neighboring Town thus, the said electric service are awarded to them with a total amount of **SEVEN HUNDRED THOUSAND PESOS ONLY (Php 700,000.00)** only:
