	SERVICE SPECIFICATION:			
	1. TERMITE BAITING SYSTEM			
	A. PERIMETER - This will be done by installing baiting stations around the building at points near where termites are likely to be foraging in the ground for food. The stations contain non-toxic food preferred for termites. The stations are inspected every quarter for evidences that termites have found some of the stations and are feeding on the interceptors. Requiem termite bait added to the stations after termites are found feeding on the interceptors.			
	B. INFESTED AREA TREATMENT - Insertion of granular termite bait directly to the infested area of the building by dusting the bait inside using a puffer or granules dispenser, after the treatment, the termites carry the dust particles on their bodies and eventually back to the nest (wherever that maybe) via transfer effect and it takes only a month to eliminate the infestation.			
	2. FREQUENCY OF TREATMENT			
	A. ONE GENERAL TREATMENT - Installation of termite In-Ground baiting station and insertion of granular termite bait on the infested and non-infested area.			
	B. Free Follow-up Treatment on the infested area for the next Thirty (30) days from the general treatment.			
	C. Free Four (4) quarterly follow-up treatment in one year.			
	GENERAL PEST CONTROL			
	This services is designed for the purpose of controlling of different kinds of roaches, bugs, flies and other flying and crawling insects by spraying of liquid formulation or gel bait application it depends on the situation of the area. These also include installation of rat bait station in strategic location within the perimeter to cover the control of all species of rodents using our mechanical devices, glue, and/or slow or fast acting chemical rodenticide or combination of both are used for this type of service.
